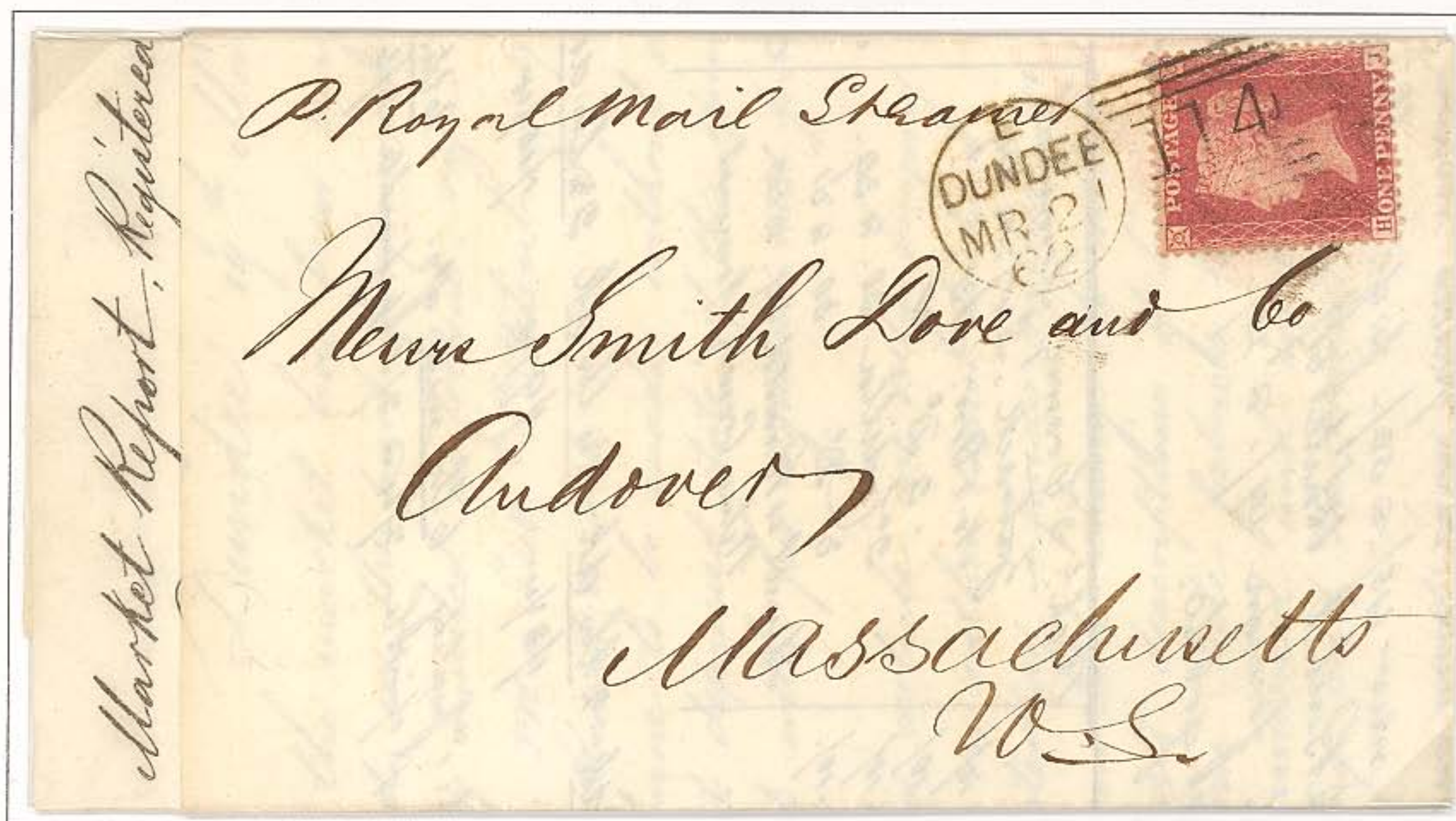

2¢                  postage due in Andover (not shown)

Notes: Printed market report of Allan Edward and Company, registered for foreign transmission with the General Post Office, London to qualify for the reduced rate of one penny. Circular prepaid with 1d adhesive (Scott No. 20). This report was cleverly folded so that the top line, which shows to whom it was registered, was observable at the left side.

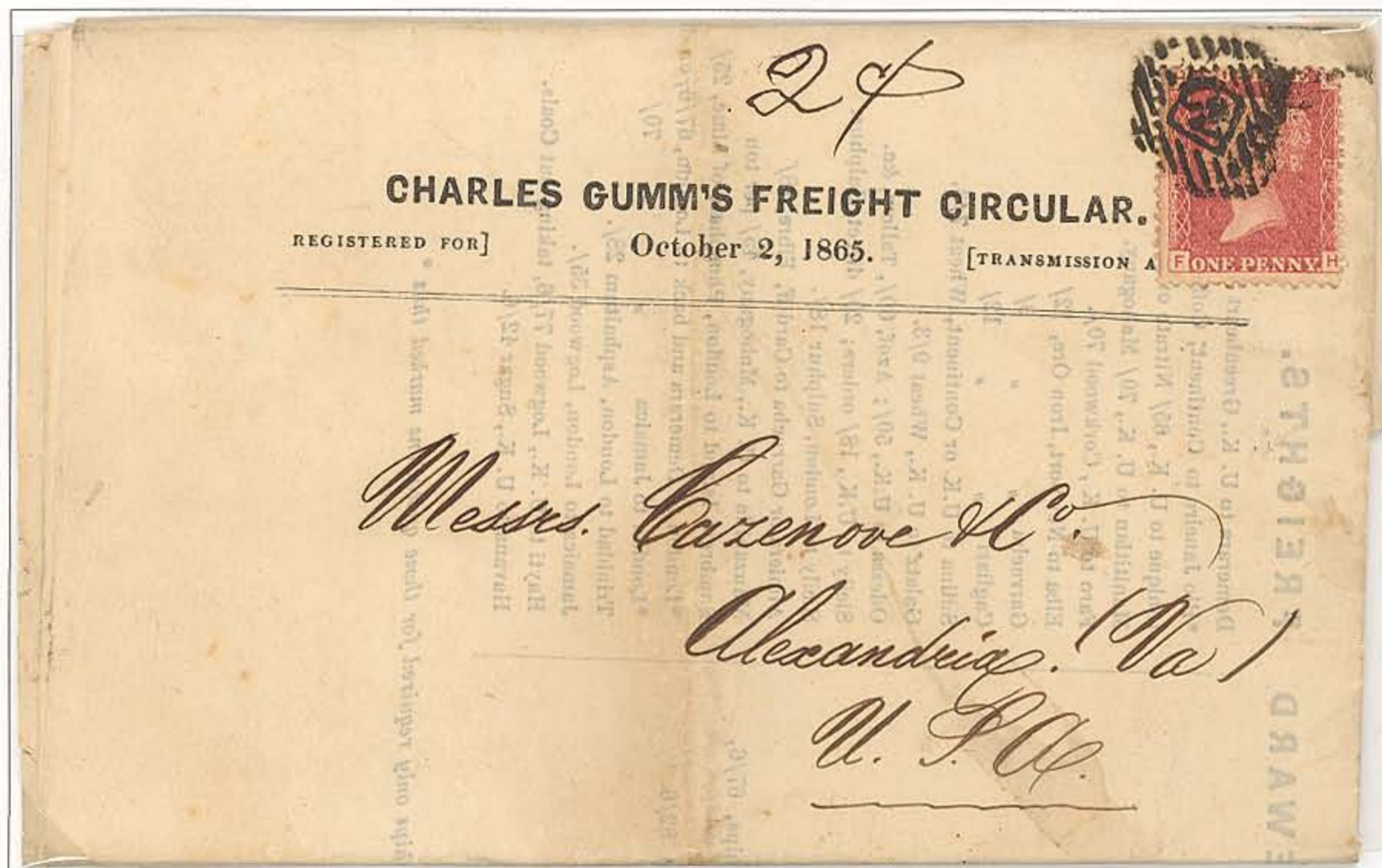

Notes: *Charles Gumm's Freight Circular*, registered at the General Post Office, London, to qualify for the reduced rate of one penny. Multi-page circular paid with one penny adhesive, Scott No. 33, plate 82. Alexandria postal clerk marked 2¢ postage due, infrequently seen on printed matter.

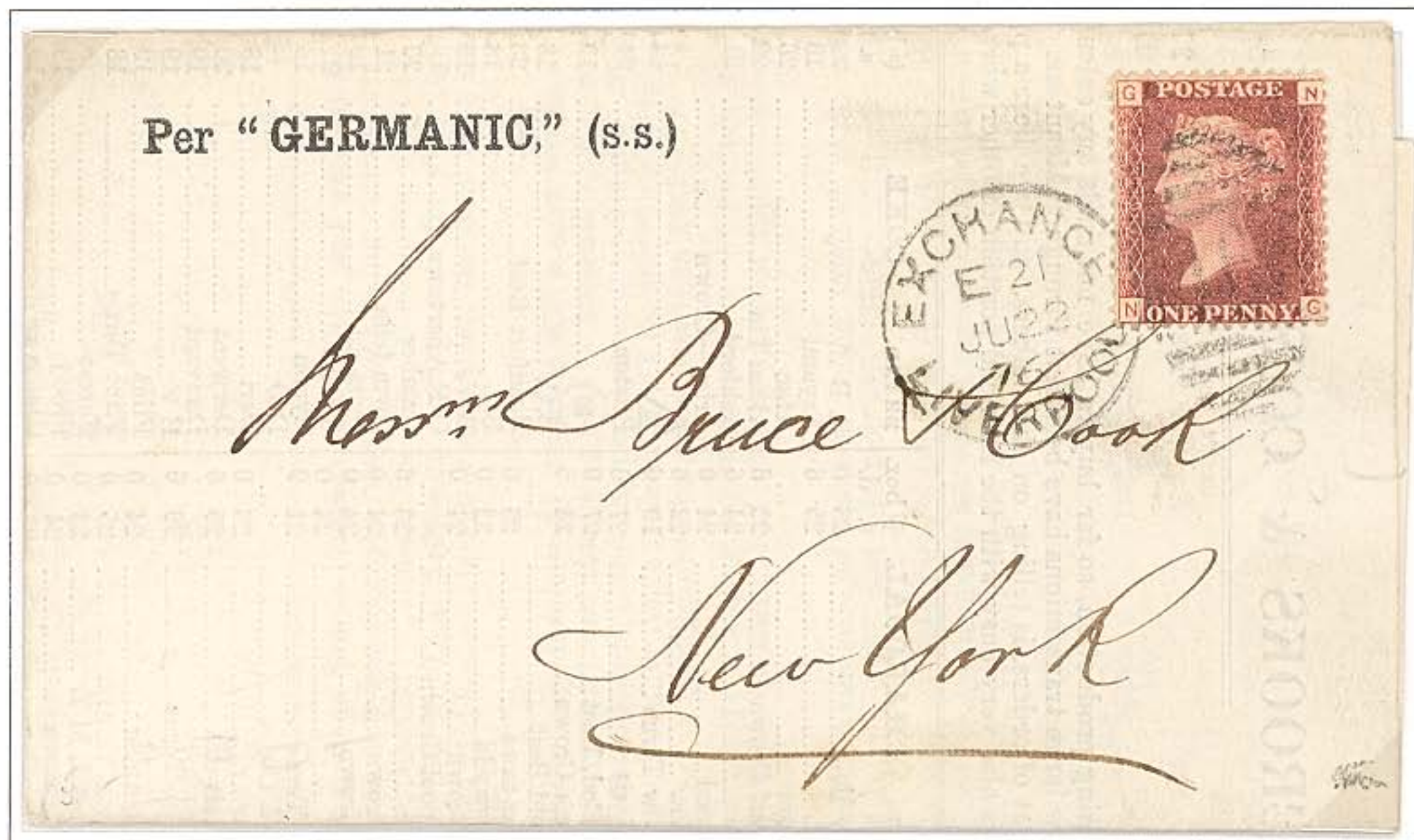
