


This official mailing has all the characters in play for it be an official one. It is marked official business, the imprint FREE, and Mr. John B. Dimitry to sign for it. The Powell type 6p postmark dates the cover to 1865.

The Postmaster General and various other Post Office Department officials were allowed to send official mail free of postage when endorsed "Official Business" over their signatures. There are two distinct groups of official envelopes — the first, for the Post Office Department at the seat of the government in Richmond, Virginia; and the second, for the Trans-Mississippi Agency, located at Marshall, Texas.

This cover from the Auditor's Office contains a circular requesting an accounting of the unpaid service rendered for the United States Postal Service until the Confederate States Postal Service took over the mail. Mailed late in December of 1861, it is not received until January 2nd, 1862.




The Confederate Ordinance Laboratory at Brown's Island near Richmond is the site of an accidental explosion. 69 factory workers (62 of whom are women) are either killed or injured as a result of a worker's carelessness. The fact, that such a large proportion of casualties at an industrial site are women, is the direct result of the Confederacy's declining manpower.



This cover illustrates the free franking of the Post Office Department.

This Richmond CDS was used until July 19, 1861 and brought back into use on July 31, 1861, and again on August 4, 5, 6, 1861. These last usages may be attributed to a heavy mail load after the first battle of Bull Run.

This official government envelope carries a circular to the postmaster at Ayletts, Virginia. Its contents has information about the requisition for blanks and other post office articles. But, inside the circular, is a note stating that this envelope was taken from the rebel mail at Ayletts.

General U. S. Grant has begun to issue orders pursuant to his grand strategy of advancing against all the Southern armies on all fronts. Banks is directed to advance on Alabama; Sherman will move against Johnson and the Army of Tennessee in Georgia; Sigel will move down the Shenandoah Valley; Butler will turn toward Richmond; and the Army of the Potomac will advance against Lee and the Army of Northern Virginia.
