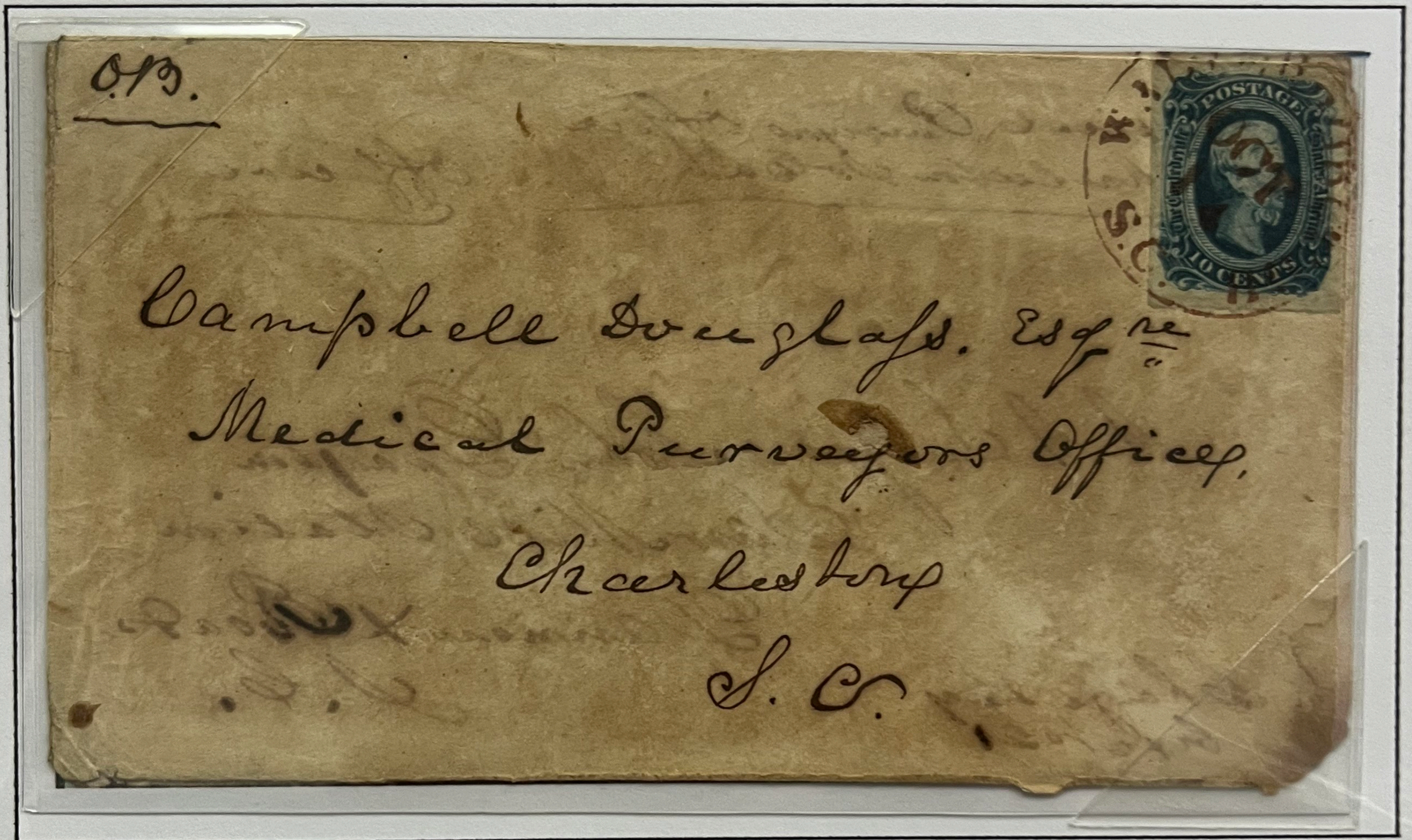

Walterborough, Colleton District, SC to Charleston, SC



12 (Keating & Ball) tied by a reddish-brown 30mm WALTERBOROUGH SC CDS, dated OCT 14, on a turned cover. Addressed to Campbell Douglass Esq., Medical Purveyors Office, CHARLESTON, S.C. Manuscript "OB" (Official Business). Second usage stampless cover with a black 32mm YD CHARLESTON SC CDS, dated OCT 26 and handstamps "Circle PAID 10" (Dietz Type IV) from Medical Purveyors Office, Charleston SoCa. Addressed to A. A. Surgeon John Drayton, Sam Mills Station, DANNERS X ROADS, S.C. No. 122

Campbell Douglas was a private in Company B, 25th SC Infantry (Eutaw Reg't). He was 35 years old when he mustered in at Charleston SC on Feb. 24, 1862, for 12 months. On July 29, 1862 he was detached to the Medical Purveyor's Office as an apothecary. He extend his service on Dec. 18, 1863 until June 1864. By Special Order, SPO 277 from Gen'l Beauregard. He was captured at Wilmington, NC on Feb. 20, 1865 and sent to Point Lookout, Camp Hamilton Military Prison, VA. After signing the oath of allegiance, he was released May 13, 1865.



A. A. Surgeon John Drayton, who lived at Drayton Hall, Charleston cared for enslaved workers who built earthen fortifications in defense of Charleston, SC. He survived the war lived to 1912.

WALTERBOROUGH SC- Black 30mm WALTERBOROUGH CDS, dated Jan. 27, 1862. Handstamp "PAID", "5", Dietz Type IA, New CSA Catalog Type B. Addressed to Col. Joseph Glover, GRAHAMVILLE, So Ca. Manuscript notation: A. H. Turners (sic)-Sale of 1862 Margaret & child for \$1400-advanced him \$600 of it & note for balance



WALTERBOROUGH SC- Black 30mm WALTERBOROUGH CDS, dated Mar. 23, 186-. Handstamp "PAID", manuscript 20, Dietz Type I, New CSA Catalog Type A, ms 20. Double weight usage. Addressed to Dr. William H. Huger, Broad St., CHARLESTON, SC.
