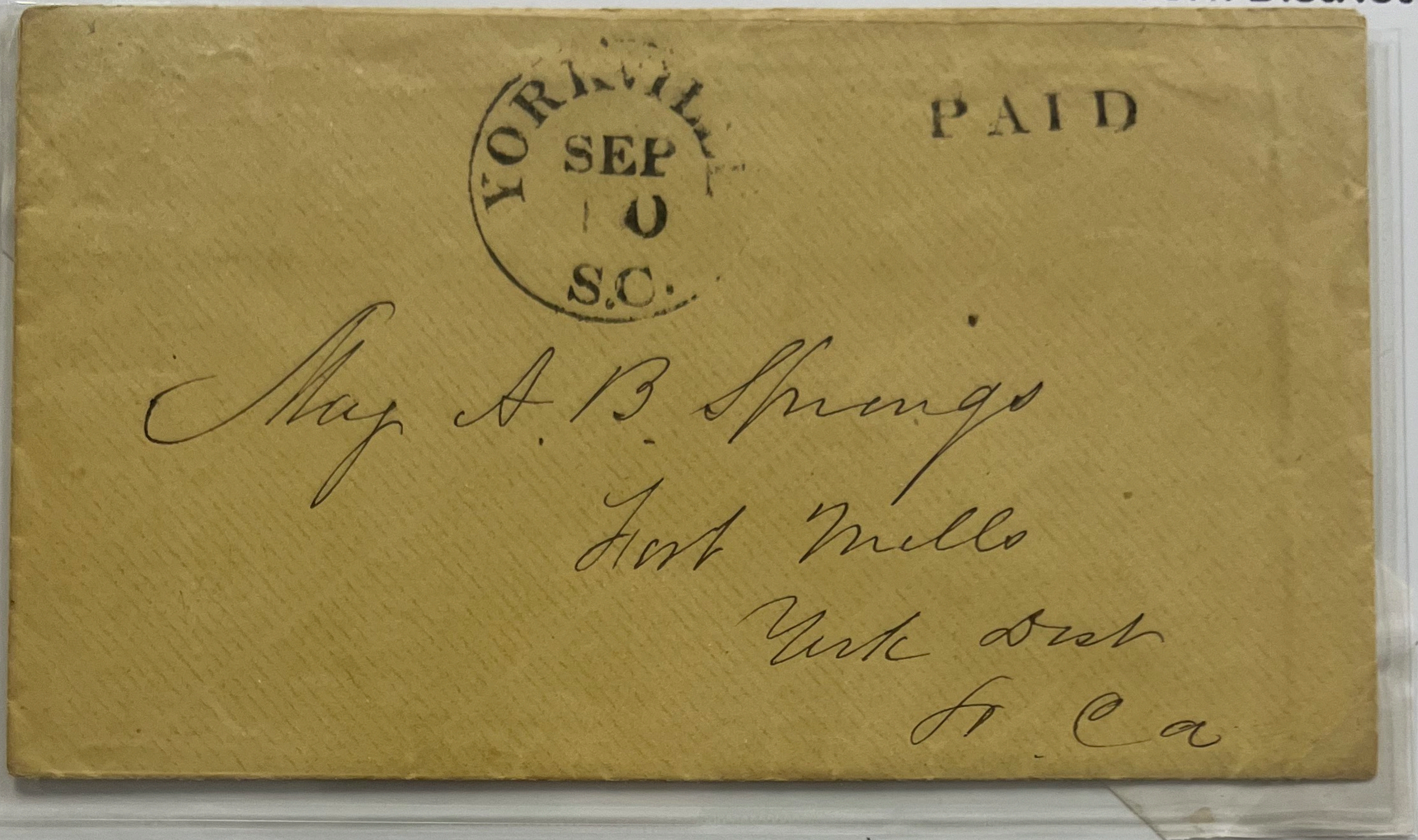

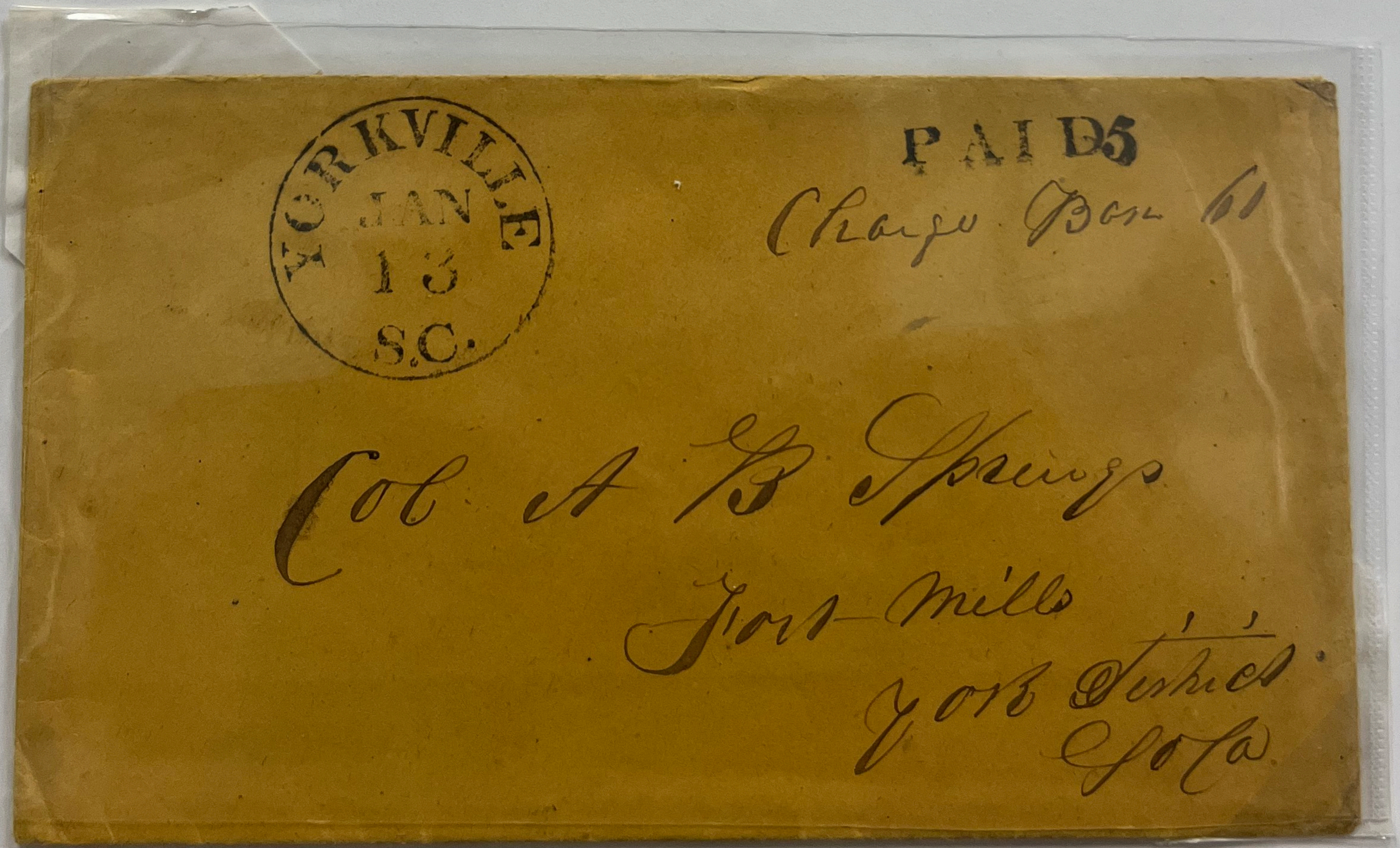

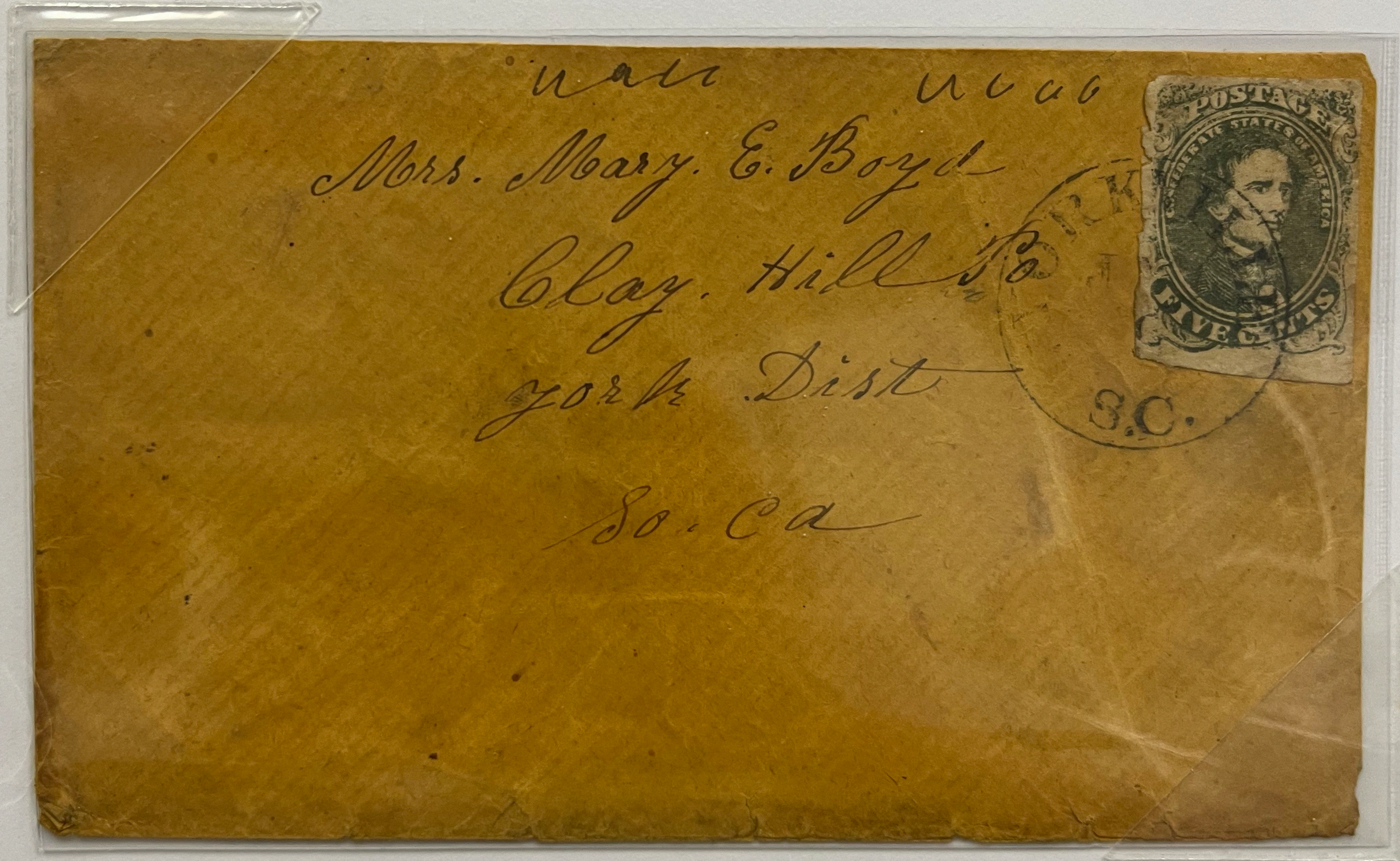
William O. McKeown was a private in Co. C of the 17th SC Reg't. He enlisted on Dec 27th 1861 and was mustered in at Camp Hamilton by Lt Col. R. Martin. He was wounded at Manassas in 1862 and later captured. He was paroled on Sept. 30, 1862. He was killed by a sharpshooter on July 6th 1864 at Petersburg, VA.
