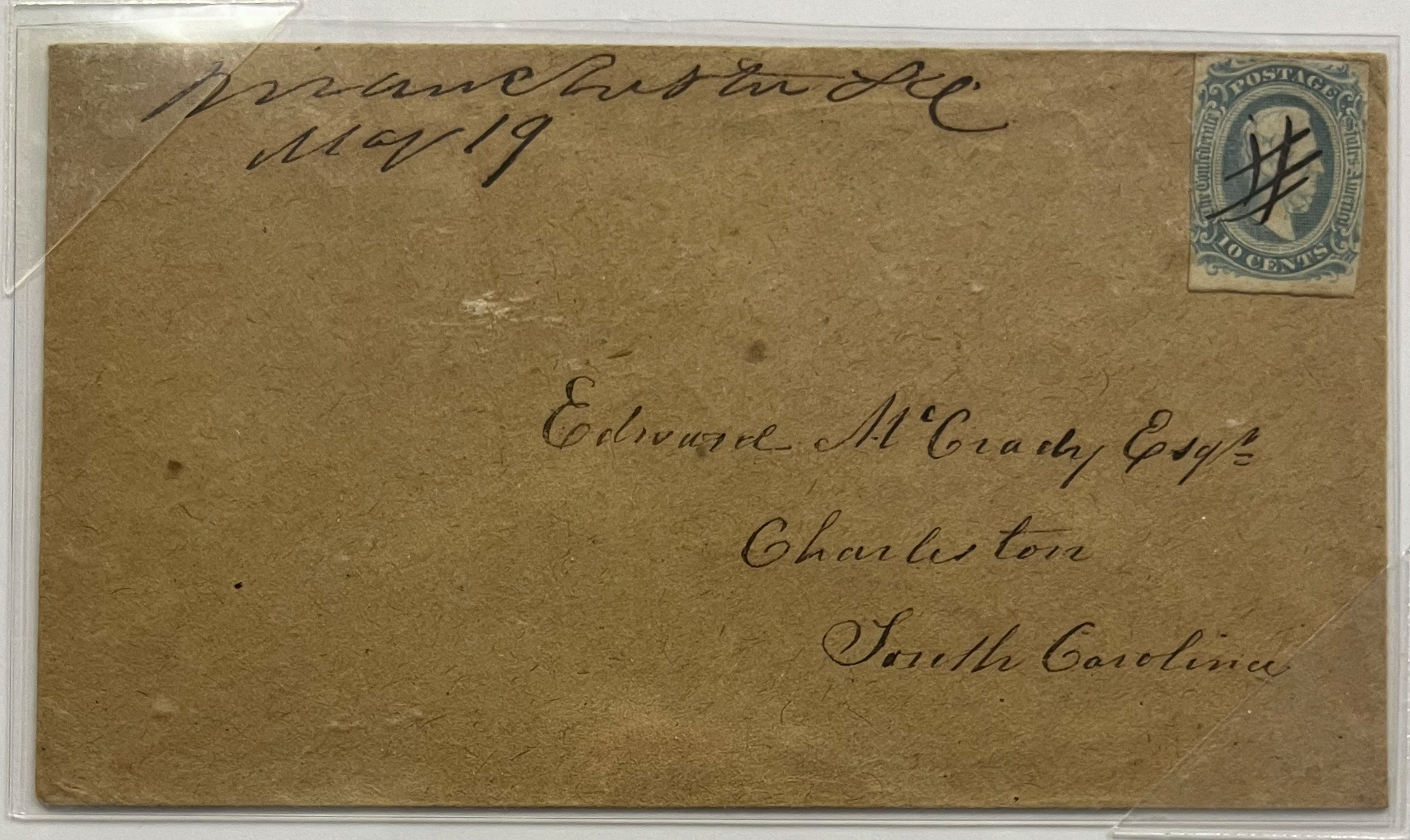

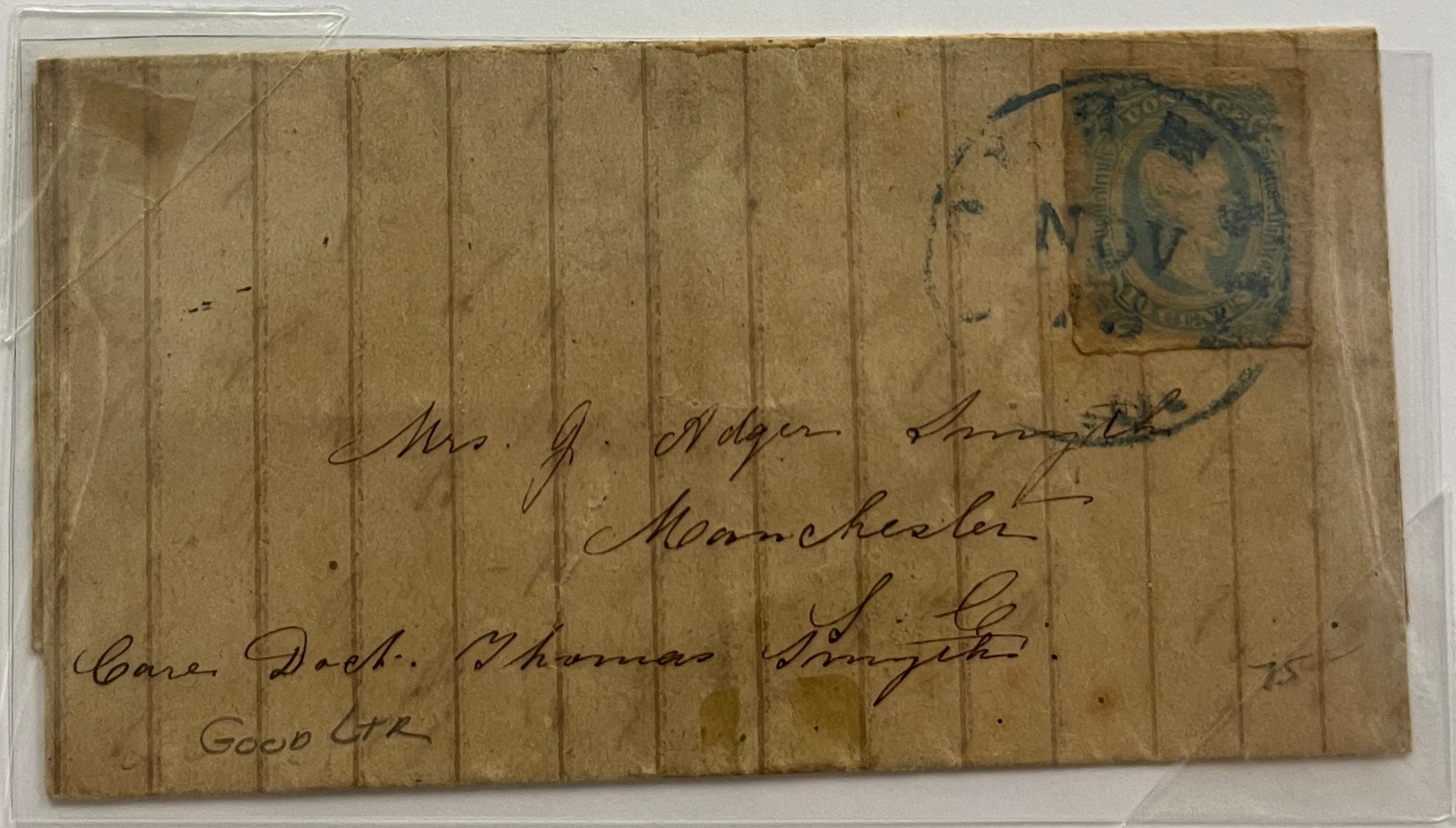

Columbia, S.C. Nov 11th 1864

Dear Annie,

Want you to help a poor soldier's wife out of some trouble? Mr. Townsend, you know, has been in the service ever since the war began, and is now running for Commissioner in Equity for Marlboro Dist. The election comes off the first week of Session, and I write to beg you and Mr. Smyth to do all you can among the Clarendon, Sumter, and Charleston delegations. Annie, you used to be a good friend, both for Annie and Mr. Townsend and now for this simple favor I hope you will not refuse me. It has been a long time since I heard from you. I believed I learned sometime ago that you had two children. I have had two. But lost my youngest last December. He was four months old. Do write me a long letter won't you? I wish to you luck, and will write again if Mr. Townsend is elected. All the Hill people are very well. Ellen is about grown now, and is quite pretty. Dear Annie, excuse me this time I have a good deal of writing to do. Allis joins me in love to you and kisses to your little ones. My kind regards to Mr. Smyth. If he isn't with you, please write to him. As ever your affectionate friend

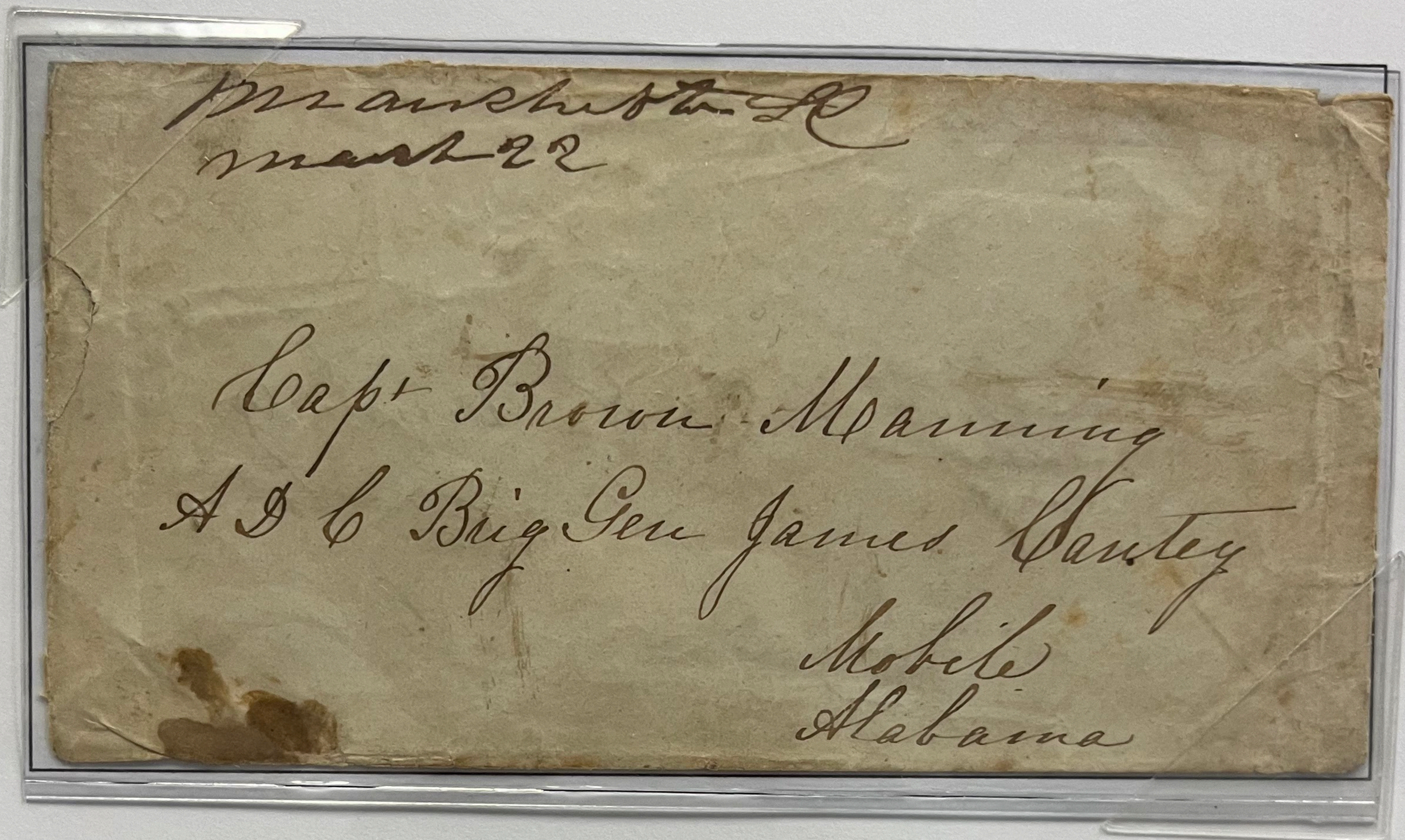
