TERMS AND CONDITIONS

- 1. This certificate is not a valid obligation unless a United States War-Savings Certificate Stamp of the Series of 1918 is affixed hereto.
- 2. This certificate is of no value except to the owner named hereon, and is not transferable.
- 3. Not more than twenty United States War-Savings Certificate Stamps, and only such Stamps of the Series of 1918, may be affixed hereto.
- 4. This certificate may be registered at any post office of the first, second, or third class, subject to such regulations as the Postmaster General may prescribe. Unless registered, the United States will not be liable if payment be made to a person not the rightful owner.
- 5. This certificate, if not registered, is payable at any money-order post office, and on January 1, 1923, at the Treasury Department in Washington, but if registered, is payable only at the post office where registered. No post-office, however, is required to make payment, either on January 1, 1923, or on any other date, until ten days after receiving written demand therefor.
- 6. The law provides that no one person shall at any one time hold War-Savings Certificates to an aggregate amount exceeding One Thousand Dollars.
- 7. Upon payment hereof, this certificate must be surrendered and the receipt printed hereon must be signed by the owner in the presence of the official to whom surrendered. In case of death or disability a special receipt must be signed in form prescribed by the Secretary of the Treasury. Upon furnishing evidence of loss of a registered certificate satisfactory to the Secretary of the Treasury, the owner thereof shall be entitled to receive payment of the amount for which it shall have been registered.

INSTRUCTIONS.

Buy stamps only from a post office, bank, or other authorized agent. Every agent will have official authority to sell War-Savings Stamps.

Affix stamps to the certificate as soon as purchased. When the owner of a certificate determines to register it, any stamps added to the certificate after registration must also be registered at the same post office.

The inclosed certificate with one or more stamps affixed represents a five-year loan to the United States Government. If the necessities of the owner are such as to require the repayment of the amount invested, the certificate is made payable at the option of the owner named thereon at any time prior to maturity, and in case of such payment such owner shall be entitled to receive the amount set forth in the table printed on the certificate for each War-Savings Certificate Stamp then affixed.

INFORMATION.

There are two kinds of stamps, War-Savings Stamps and Thrift Stamps. The War-Savings Stamps vary in price from \$4.12 to \$4.23, according to the month in which purchased. They increase in value every month, and if held until maturity, January 1, 1923, they earn 4 per cent interest compounded quarterly.

Spaces are provided on the War-Savings Certificate for 20 War-Savings Stamps. For each of these stamps affixed to the certificate the United States Government will pay you \$5.00 on January 1, 1923. If you fill all the spaces by affixing 20 stamps, it will pay you \$100.00 January 1, 1923.

The 25-cent Thrift Stamps do not earn interest. When 16 of them are affixed to the Thrift Card the holder may surrender the card and upon paying 12 to 23 cents receive a War-Savings Certificate

Stamp, which earns interest.

NOTICE TO POSTMASTER.

When a lost Way Savings Certificate reaches you, by hand or through the mails, you will take prompt steps to deliver it to its owner, whose name and addres appear upon the certificate. If the owner can not be reached you will by bulletin or advertisement to the public, endeavor to find the owner it, after thirty days, you are unable to find the owner you will forward the certificate to the Postmaster General, Washington, D. C.
