LINN'S PLATE II Sheet 2 and 11 and PLATE IV Sheet 13



Sent from Hermosillo on august 11 1913 and received at Magdalena the 12th. Cover franked with white stamp one cent (Scott 322) and two green seal stamps, 1 & 3 cents (Scott 336 & 337) all stamps are colorless rouletted.



Cover from Magdalena Sonora, august 11 1913 and received at Nogales, Sonora on august the 18th 1913. The franking is paid with white stamps 1 and 2 cents (Scott 322 & 323) and 2 green seal stamps of one cent (Scott 336), all stamps are colorless rouletted.

LINN'S PLATE II Sheet 2 and 11, and PLATE III Sheet 3.



Cover sent from Hermosillo, Sonora on august 11 of 1913 and received the 13th at Magdalena, Sonora. The rate is completed with two white stamps of 1 and 2 cents (Scott 322 & 323) and two green seal stamps of one cent each (Scott 336) all stamps are colorless rouletted.




Cover sent from Hermostilo, Sonora, to Nogales, Sonora, with white stamps of 1 and 2 (wide) cents, Scott numbers 322 and 323. And two stamps with green seal of 1 cent each one. Scott number 336. Cancellation date, August 13, 1913.





Register sent from Hermosillo, Sonora, to La Poza, Sonora, franked with three white stamps of 1,2 and 10 cents, rouletted at both sides and bottom in colorless lines, Scott number 322, 324 and 328; and two revenue stamps "transitorio" also called "ejercito", Scott number 347. Cancellation date at front is Jan 4 1913 because a mistake of the postal office who forgot to change the year of the device and leave 1913 instead of 1914, the photograph exhibited shows the envelope back where you can see clearly the correct date of Jan 4 of 1914.



Cover sent from Magdalena, Sonora, franked with strip of 2 1/2 stamps.

Scott numbers 323 and 324 var, 1913 tied by Magdalena cds, city mail rate. The two whole stamps are Scott 323 the half stamp used as 1 cent, Sccott 324 var, se-tenant with the 323s. Cancellation date

September 3, 1913.

Cover from Magdalena, Sonora, franked with 2 singles.

Scott numbers 323 and half stamp used as 1 cent, tied by Magdalena, Son. cds, city mail rate.

Cancellation date

September 5, 1913.

Cover from Nogales, Sonora, to Hermosillo, Sonora, franked with two white stamps of 2 cents each, Scott 323 and 324, one stamp of 10 cents with green seal, Scott number 339 and one stamp of 1 cent revenue "transitorio", also called "ejercito", Scott number 347.

Cancellation date
December 31, 1913.



Cover sent from Hermosillo, Sonora, to Magdalena Sonora, with white stamp of 3 cents, Scott number 322. Cancellation date, August 8, 1913

LINN'S PLATE I Sheet 5



Commercial letter sent from Cumpas, Sonora the 8 of October 1913, arriving to Hermosillo, Sonora on October the 11th. The franking was paid with 5 cent white stamp (Scott 326), this was the original and must common rate for letters travel in the Sonora state and sell off very promptly, and is very difficult to find this stamp on cover. The stamp is rouletted with white lines.



Cover sent into Hermosillo, Sonora, to the same city as urban mail, with stamp of 10 cents, Scott number 328, with cancellation date,

July 10, 1913


Open correspondence sent from Nogales, Sonora to Magdalena Sonora, with 1 cent franking, printed mater rate and open correspondence rate and is a very rare usage for this issue. Cancellation of Nogales on November the 5th 1913 green seal stamp (Scott 336), colorless rouletted.



Letter sent from Nogales, Sonora on July 25 1913 received at Magdalena, Sonora, on July 26, franked with two green stamps of 1 cent (Scott 336) and one green seal 3 cents. stamp (Scott 337), rouletted in colorless lines.

The most usual rate was 5 cents, that is why this stamp sell off very soon and the franking was completed with lower denominated stamps.

Cover from Magdalena to Nogales, Sonora dated September the 15th 1913. The cover present a 10 cents green seal stamp (Scott 339)this rate was used to pay a registered rate. Over rated rate showing the number one post mark of Nogales, Sonora. The stamp is a colorless rouletted.


LINN'S PLATE XX Sheet 29 and PLATE XXI Sheet 30





Commercial letter with 5 cent franking, franked with green seal stamps of 2 and 3 cents (Scott 342a & 343) . Post mark from Hermosillo where is the letter origin on September 18 1914 to Magdalena, Sonora arriving the next day.

LINN'S PLATE XIX Sheet 28




Sent from Nogales, Sonora to San Javier, Sonora when Venustiano Carranza and Francisco Villa, break relations, this event provoke that Mr. Francisco Rocha the post manager at Nogales run away took with him stamps and cancellation devices to the south. This letter shows the provisional post mark used with the México name on it, this post mark was in use only from august 30 to October the 1st 1914, is a very rare example with 5 cents stamp (Scott 345), black rouletted.



Letter from Nogales, Sonora to Guaymas, Sonora showing the new cancellation that replace the México provisional. Canceled at Nogales October the $2^{\rm nd}$ 1914 and received at Guaymas October the $4^{\rm th}$. Franked with 10 cent black rouletted (Scott 346).
