

John Henry Prontaut (Jean Henri Prontante) (1842-1898) was born in New York City. His father, a watch maker, was born in Paris and his mother in Versailles. Prontaut (seen with various French and Americanize spellings) was in Co. A of the 21st Georgia Cavalry, the 7th Georgia Cavalry as well as Co. B, 1st Georgia Bn Loc. Def. Infantry. The 7th was formed by a consolidation of the 24th Batt. Ga. Cav., four companies of the 21st Batt. Ga. Cav. And the two companies of the Hardwick Mounted Rifles.


