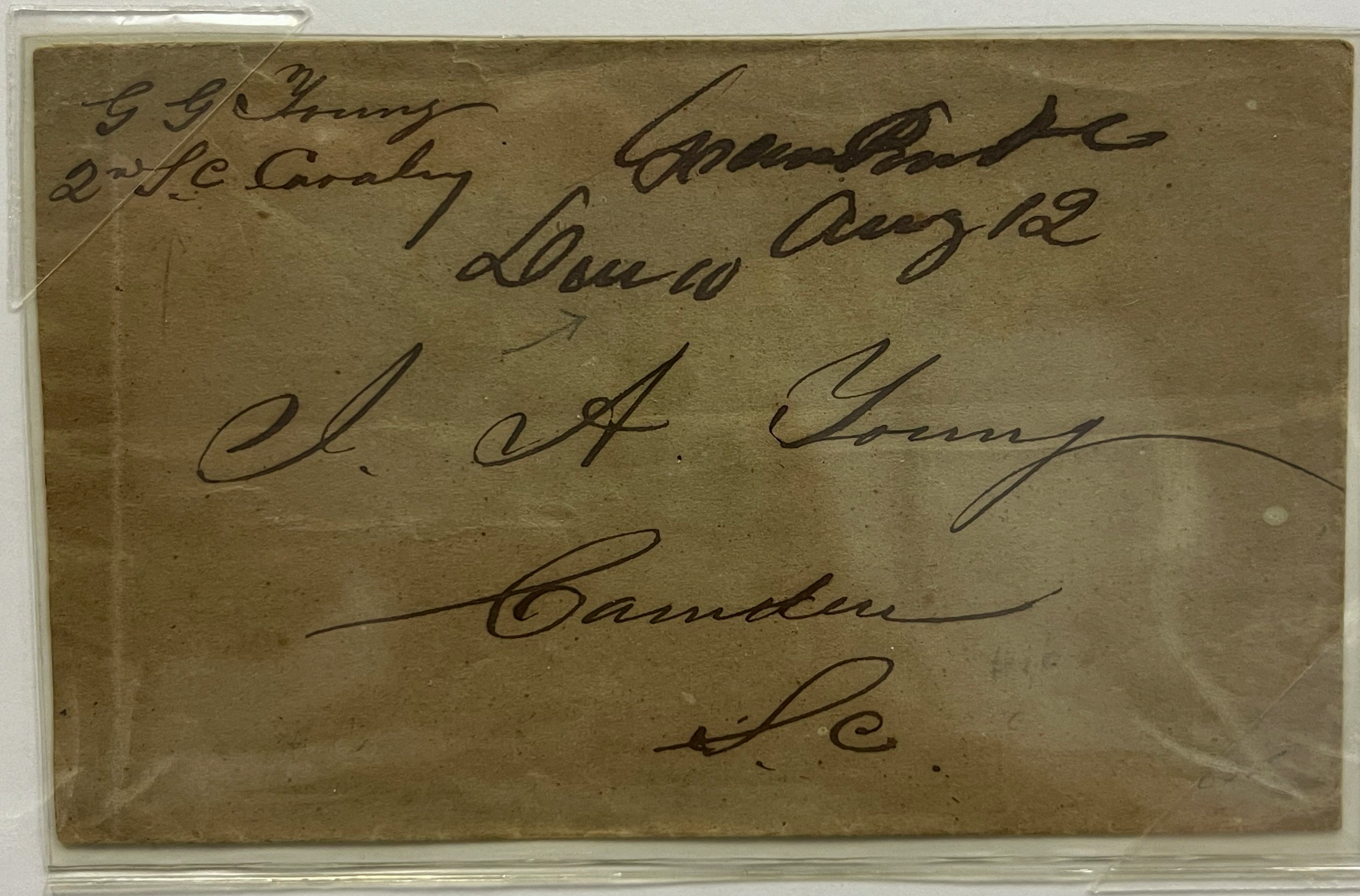

Manuscript notation "or Sargt Elkins same mess". Cover was forwarded from GREEN POND to EDGEFIELD C. H., with manuscript ink forward and pencil Due 10 (EDGEFIELD C. H.). No. 327

John P. Bates was an Ordinance Sergeant in Company F of the 2nd Reg't SC Cavalry. He enlisted on July 1, 1862 for two years. He was detailed to the Service Ordinance Dept. on July 1, 1862. He was wounded in action on Nov. 5, 1864 and subsequently died of a fever.
