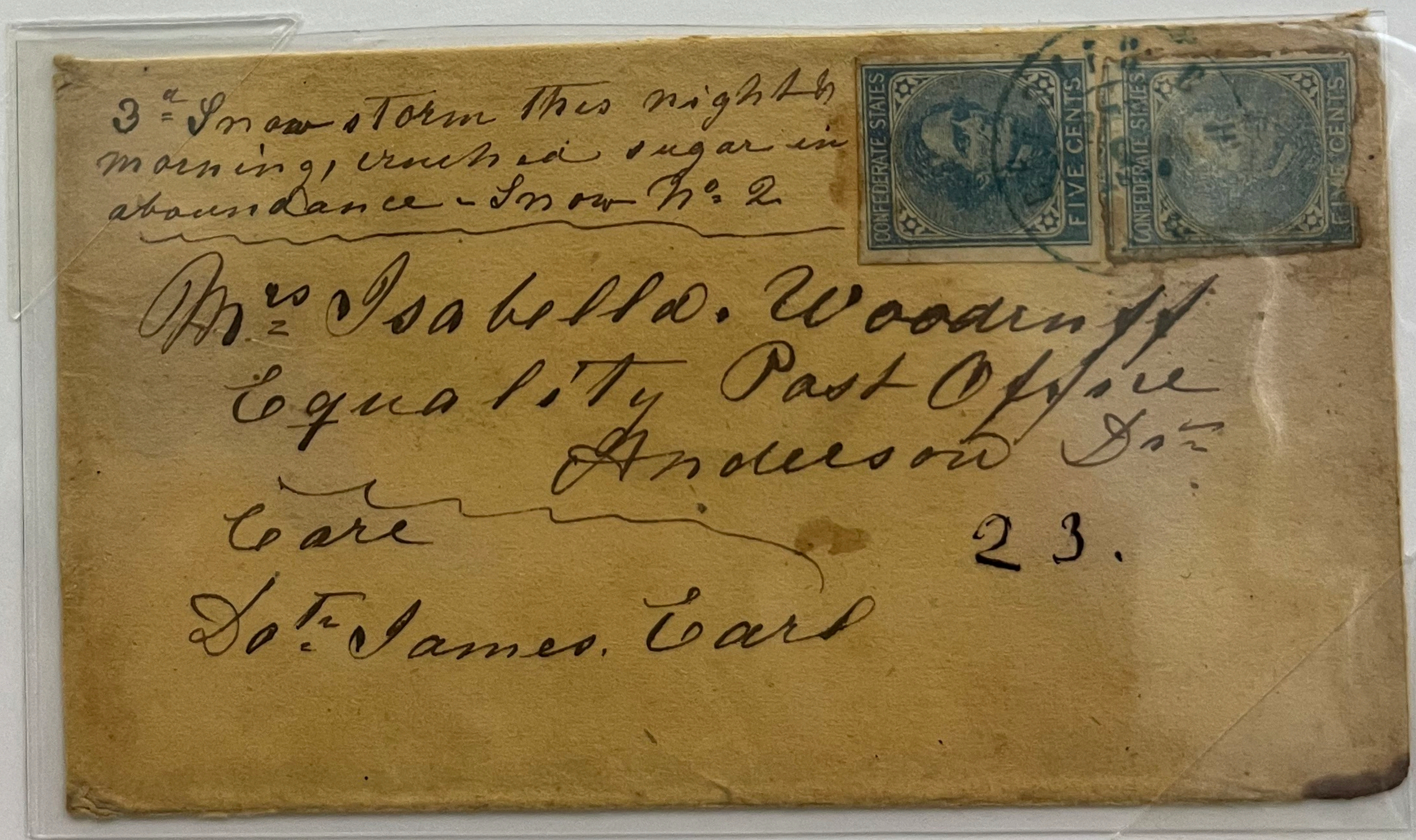

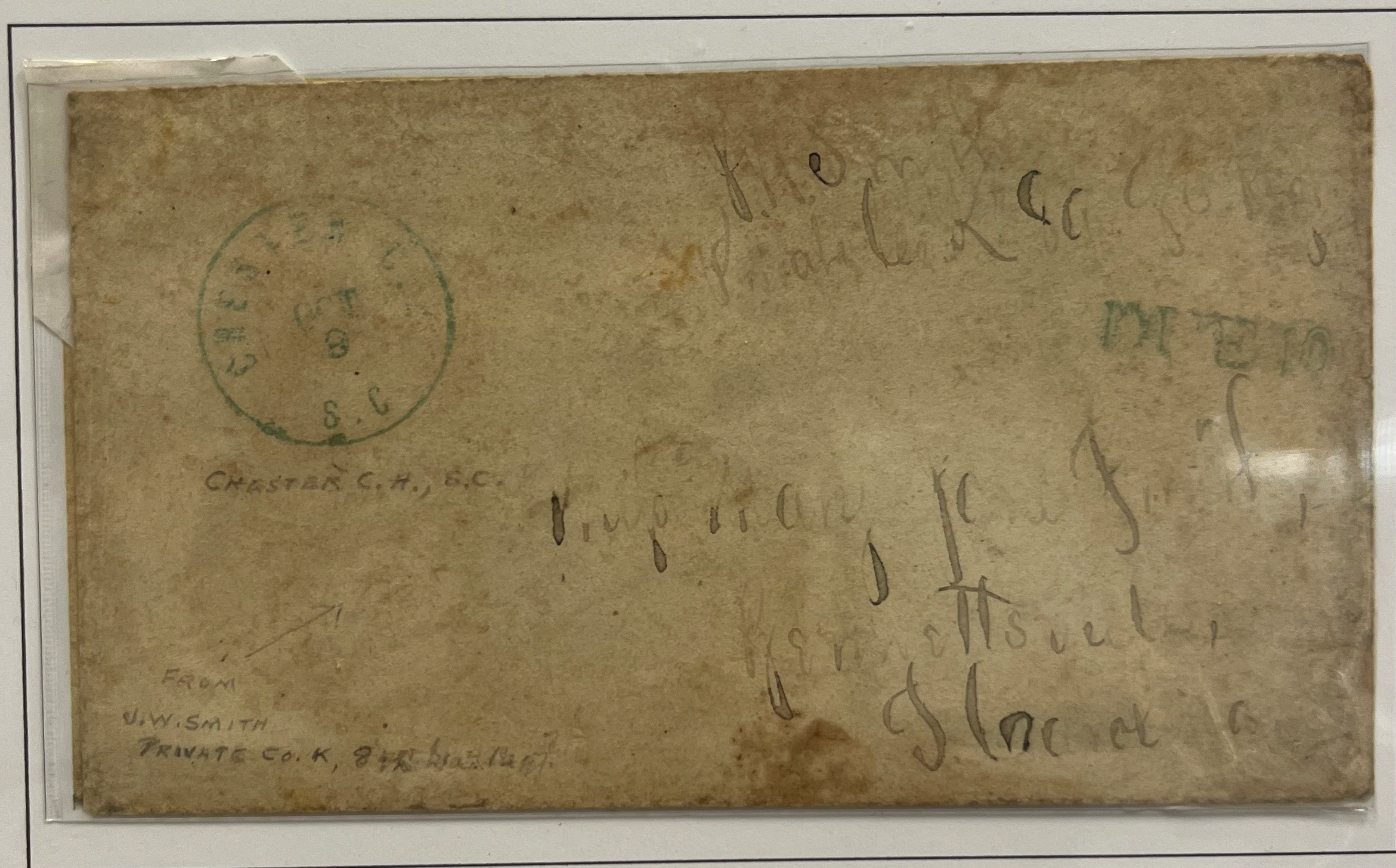

26mm Blue/Green DC CHESTER C. H. CDS, dated Oct. 8, (no year date). A soldier's letter with a blue/green Handstamp DUE 10, blue is listed in Dietz, New CSA Catalog Type E. Soldier's letter from J. H. Smith, Private, Co. K, SC 8th Reg't. Addressed to Miss Hony Smith, Chester, S. Carolina. ex -Lemsky No. 1000

J. H. Smith was a Private in Company K, 8th Reg't SCV. He enlisted on April 13, 1861 for 12 months. He was appointed Sergt. Until June 18, 1861. He became sick in the fall of 1861 through early 1862 and was at hospitalized. He rejoined his Reg't but again was hospitalized at Lynchburg, VA in Jan. 1863. He was appointed First Sergt and on Apr. 20, 1863 was put on light duty as clerk at Winder Hospital. He was captured at Richmond on Apr. 5, 1865 and paroled on Apr. 24, 1865.
