

They corresponded primarily with Mrs. Daniel Crawford and Miss Katherine Crawford (sister or wife). Capt. Daniel H. Crawford's covers are addressed to him as serving in McLaw's Division in 1863, and later in Longstreet's Division. He was also in the 15th Reg't of the SCV and in the Signal Corps. John Crawford was in Kershaw's Brigade, McLaw's Division in No. 1252
