

Jesse W. Norris was a personal friend of James Orr (Orr's Rifles). He was born in 1817 in Anderson District. The Rank of Colonel was honorary. He was a lawyw=er in Pickens District and served two years in the SC Legislature. He serve on the staff of Gov. Aiken. In 1863 he joined the 1st Reg't SC troops as a private and was then appointed Sergt. Major of the Reg't. He returned to Anderson District after the war.

My best Sir. Yours of the 17th was Rec'd last night and I am obliged to you for your prompt res. And candor of your response. I feel it is my duty and pleasure to - to give you the cause of my first note of inquiry- Some friend said around my table that you were not returning nor paying on your bond. I was pointedly asked if you were I thought you werewas not certain tho - I had put the question to every man, monies loaned, moving at interest including bonds had had pointed these things out at the head of the column to all inquiries. Was aware the General Harrigan had taken the position last spring that nothing but monies absolutely advanced for the sake of the interest were taxable. I knew that he caved - and after misleading others on this point made his own return all bonds not issued by and notes of every description whether for moneys loaned, property sold, labor performed or xxxx from whatever source derived - I was fearful that you had without reflecting taken & was acting out of his first position - if so I knew. However unpleasant to me. I should be forced from a sense of duty to issue against you & bring your case up before the department - Your letter relieves me greatly the - I should like to meet you at any time & and particularly to see you at my house but not to satisfy me on your return, Your letter is explicit - If however upon reflection you conclude that it needs any amendment. I shall be at Anderson on Wednesday 23rd inst. also sale day in May - either day will be in time - Should be glad to see you on either business or socially.

James L. Orr at 39 years old, raised Orr's Rifles, which initially trained at Camp Pickens, Sandy Springs, SC. In December 1861 he was elected SC's CSA Senator, resigned his commission, and in February 1862 went to Richmond, Va. He served throughout the war and on Nov. 26, 1865 was elected South Carolina Governor. After his governorship, he was appointed a circuit judge. In 1873 he was appointed US ambassador to Russia. In May 1873, he died of pneumonia in Russia. During 1866 and 1867 he served as the Grand Master of the SC Masons.
